VpCl™ CorrCaps are used by placing on the ends of electrical connectors, engines, brakes or many other exposed components. Typical application include corrosion protection of disc braking systems during assembly operations and factory road testing. The CorrCaps remain in place until pre-inspection at the dealer, where they are taken off of the brake assemblies. The VpCl™s volatilize and migrate with air and condense on metal surfaces, forming a thin, uniform and extremely effective corrosion inhibiting barrier.

The elastic cap allows for a tight fit on vulnerable surfaces and is easy to securely apply. The product can be reused for up to 1 year.
